**REPORT OF
DISTRICT 94 LEADERSHIP COMMITTEE
FOR YEAR
JULY 1, 2019 – JUNE 30, 2020**

Introduction

The **District Director**, District 94, DTM Rokiatsu N'Diaye, **appointed** me DTM Abayomi Aiyesimoju, as **Chair** of the District Committee on the **10th of August, 2019**.

On the **16th of November**, the District Director, based on the recommendation of the District Leadership Committee Chair, **appointed the full District Leadership Committee of nine of us as members**.

DLC Committee Members

DEADLINES FOR NOMINATION (INITIAL AND EXTENTION)

- The initial deadline of **31st December** for nominations was extended **Till 14th February** by an **email** sent to council members on the **8th of February. 2020.**
- The extension was done because of **new regulations** we received from TI saying that **only those who already apply to the DLC and have been interviewed and evaluated by the DLC can come as floor candidates if they so wish and indicate** and no more floor candidates just coming from the floor on the day of election.
- The extension was to give more people the opportunity of applying.

Our Assignment

Our **assignment** was to:

- (1) **Seek out and receive nominations** for prospective district officer candidates;
- (2) **Verify** that candidates meet **eligibility requirements** for the offices they seek;
- (3) **Evaluate, screen and interview all candidates who apply. All candidates, including those who may be floor candidates at the election were to undergo the DLC evaluation, screening and interview process;**
- (4) **Nominate** candidates ;
- (6) **Report on candidates'** nomination.

Offices Open for Elections

The offices for which we were to nominate candidates and the minimum number of candidates per office were as follows:

A minimum of:

- (1) One (1) candidate each for the offices of District Director and Program Quality Director;
- (2) Two (2) or more candidates for the office of Club Growth Director;
- (3) And a minimum of one (1) candidate for Division Director for each of divisions A, B, C, D, E, F, G, H.

Conditions for floor candidates

All candidates who having not been nominated but have gone through the DLC evaluation and interview process and want to come as floor candidates were required to let the DLC know in writing after the publication of the list of nominated candidates and latest 7 days before the election.

Only such candidates who indicate their desire to run as floor candidates after going through the DLC evaluation will be on the list of eligible floor candidates at the election.

Guidelines on Eligibility

We were given guidelines on eligibility and qualifications for each office.

Candidates were required to complete the following forms:

- (a) Candidate Application Form,
- (b) District Leader Nomination Form
- (c) District Leader Biographical Information Form and
- (d) Officer Agreement and Release Form.

We also had at our disposal, Candidates Evaluation Form and the District Leader Competencies Forms to help us in our assessment.

Process

- All documents received on or from each candidate were sent to all members of the District Leadership Committee.
- Every candidate was dully evaluated and interviewed. Each candidate was interviewed by at least two members of the DLC.
- Any candidates contesting for the same position were interviewed by the same set of members of the DLC.
- The results of the evaluations and interviews on all candidates were sent to every member of the DLC, for their consideration to enable them take a decision.

Process (continued)

- The **Chair** of the DLC was **not a voting member** of the committee.
- **Voting** on all candidates was **done independently** by every voting member.
- The **votes were tallied by the Chair and two other members** of the Committee.
- **Result** of the voting was **sent the members by the Chair**.
- All **nominated candidates** were **voted for the majority of the voting members of the DLC**.

Withdrawal by some nominated candidates

After the nominations were agreed upon but before the DLC report was sent to the District Director some four (4) nominated candidates withdrew their candidacy for Division Director for division A and opted for liberty to run as floor candidates for the new Division to be formed from Division A, if such a Division is formed.
